Admission procedure

Counselling Code: SVSE

Eligibility : The minimum qualification required to pursue MBA Course is any graduation.

Admission process for Convener and Management Quota

A. Convener Quota(70%) : A candidate should qualify in ICET conducted by Government of Telangana.

- A candidate who qualified in ICET needs to participate in the counselling

Documents required for attending the counselling.

1. ICET Hall ticket 2. ICET Rank card 3. SSC memo marks sheet 4. Inter memo marks sheet 5. Qualifying degree marks sheet 6. Latest Income Certificate for fee reimbursement & Scholarship 7. Caste Certificate 8. T.C 9. Aadhar Card.

Eligibility Criteria for Fee Reimbursement and Scholarships

- Full Fee Reimbursement is applicable for SC/ST/BC-E Candidates

1. For SC/ST category students : Income certificate issued from 1st January onwards of every year with income less than 2,00,000 per annum in both urban and rural areas.

2. For BC,EBC Category students: Income certificate issued from 1st January onwards of every year with income less than 2,00,000 per annum in urban and 1,50,000 per annum in rural areas.

B. Management Quota (30%): Any graduate with prescribed percentage of marks can approach the college for seeking the admission into this category.

- Fee prescribed by the government to be paid by the candidate.

Hostel facility is available for boys and girls separately on the campus.
